CSP124/16 PUBLIC FORUM

1 Member of the public was present.

CSP125/16 TO RECEIVE APOLOGIES

Apologies were received from the Police.

CSP126/16 POLICE REPORT

PCSO David Harvey emailed the clerk his report which stated the following three incidents had taken place since the last meeting:-

On 6th December 2015 there had been a report of hare coursing in the area, offenders had made off along Creeting lane towards the A1120. The vehicles, a silver Astra and a Renault were observed in the area at the time. No registrations had been seen.

On 31st December 2015 mobile patrols had located a group of males and two dogs exiting a field off Creeting Lane and getting into a silver Subaru Impreza.

On 4th January 2016 overnight offenders had forced entry to a secure vehicle that was unattended at the time and fishing related items had been taken.

CSP127/16 DISTRICT COUNCILLOR REPORT – CLLR KEITH WELHAM (report attached)

Cllr Welham reported that the Planning Committee meeting had taken place in relation to Planning Application 3328/15 - Erection of new offices, layout of new car park, erection of new industrial building, resurfacing of roadway and installation of weighbridge - the Poundfield site, and it had been well received by members. Whilst permission had been granted for the application Mr Welham reported that some members of the Planning Committee had expressed concern over parts of the application and so had the Planning Officer. They were aware of the concerns of others and stated that there would be no more planning infringements.

Cllr Welham continued that he had spoken to the Planning Officer in relation to there not being planning permission for three cranes on the Poundfield Site and that was now being investigated. Discussions were also taking place in relation to the landscaping surrounding the site. Cllr Welham explained that he had received invites from the owner, Mr Jardine, to visit the site for Parish Council Members should they wish to. It was agreed that Cllr Peacock would take up the invitation. Cllr Ashcroft suggested that Mr Jardine be invited to a Parish Council meeting in the future. Cllr Welham would arrange this with Mr Jardine.

Cllr Welham also reported that the District Council had increased their budget and he was hopeful that the Parish Council would receive part of his locality budget it had applied for.

CSP128/16 COUNTY COUNCILLOR REPORT – CLLR GARY GREEN

Cllr Green reported that due to the Government's changes for Adult Care homeowners would see on their next Council Tax Bill a new line which would state *Adult Care*. He also reported that his next budget meeting was due to be held in February. He reminded Cllrs that he had some locality budget remaining if we wanted to apply.

Cllr Green also reported that with regards to the 20mph speed limit through the village – this was still pending. Cllr Peacock stated that she had observed the road being measured so hopefully the 20mph speed limit would be put in place very soon.

Cllrs asked Cllr Green for his input into the bridge over the A14 on Pound Road. The bridge had been reported by the Clerk for its poor state by way of weeds but the work was still outstanding. Potholes also remained after endless reports to Highways. Cllr Green stated he would explore.

Cllr Green left the meeting at 8pm.

The Council would then sign the letter. As for contributing themselves towards this project Members felt this needed further discussion and therefore it needed to be put onto the Agenda for the next meeting. In relation to a contribution towards £175 for an application to the Diocese for permission for further burial ground the Council agreed to pay the full £175 to the Parochial Church Council.
